- **2**.Dickeyville Police Department has been approved for \$4000.00 WI DOT grant money, no match required. Grant will be used for new in-car camera recording system and a new dual antenna (Both directions) radar unit. The new equipment should arrive within the next month.
- **3**. On December 18th, I assisted with HGIC with implementing their required violent intruder lock down. It is required by Wisconsin's school violent intruder law that the school run through a drill and have law enforcement monitor it for any safety concerns. It went very well. The teachers reacted very quickly and secured the rooms.
- **4.** In December two people donated over \$600 and requested we help people in need for the Christmas Season. Several water bills were paid, cash given to others and paid for the meals and games at the December 18th Dickeyville Meal Site. (Around 22 people)
- 5. February 4, 2019, DARE will begin at HGIC
- **6.** Bingo is set to begin on Sunday February 17, 5 p.m. till around 8 p.m. We had a very generous donation by the Dickeyville-Kieler Lion's Club, the donation will pay roughly half of the startup cost? Thank you, Dickeyville-Kieler Lion's Club, for the donation. The equipment has been ordered.

PUBLIC WORKS:

- Ford 550 New truck has arrival date of January 29m, 2019. Tim Boldt said give or take a
 week. We then will take the truck to Drive Line in Dubuque for the Box and Plow
 installations.
- 2. Christmas decorations were taken down by Cuba City.

- 3. Meter and Cross Connection Inspections, we have been hitting this hard lately.,
- 4. We have been having foam issues at the Waste Water Treatment Plant. A Sample of mixed liquid has been sent to a lab to see if it would have any insight on this problem, so it can be treated properly. We know we have grease issues from the screw pump. It is so worn that new seals do not help. It has basically run non-stop since 1984, so it is prettyworn. There is a project that would help alleviate this problem. An early estimate would be approximately \$30,000.00 to eliminate this problem, while also helping in the treatment of phosphorus. Right now, it is very labor intensive and chemical costs are going to go through the roof. We spend about 2 hours a day working on this plus the extra chemicals we need to use. Village Board told Dale to get an engineer to look at it and let us know what we need to do to fix it. Bring information to next meeting.
- 5. Ross on Solar just don't want to forget about this. Looking at Grants for Solar Energy. It is a great way of saving money. The Village has been hit with a lot of street repairs and replacing vehicles. Every vehicle has been replaced and we are now saving money for future vehicles. If solar is the route we want to go, we need to set money aside for this. We don't want to borrow money.
- 6. SMFA State/Municipal Financial Agreement needs to be signed and sent back to DOT.
- 7. Domi Avenue Bid opening date is February 11, 2019, at 11:00 a.m. in Room A of the Community Building.
