**ORDINANCE ON SEX OFFENDERS:** Attorney Paul Johnson came to speak with the Village on the temporary Sex Offender Ordinance they passed at the February 21, 2018 meeting. The Village Board will amend the Temporary Sex Offender Ordinance at the April meeting.

**GARBAGE RATES:** On residents April Water and Sewer bill there will be a credit of \$2.66 for garbage, then there after the cost will be \$12.25 per month. This is being done in accordance with a mistake in the scheduled rate raise in the contract with Republic Services. The garbage rates will be reviewed at the July 2018 board meeting. Should a rate increase be warranted at that time, the increase will take effected on September 1, 2018.

### **PUBLIC WORKS REPORT:**

- Nothing has been decided on the Community Sensitive Solutions dollars that we have to spend during the overlay project on 61/35. The Board has until June to decide. Last month it was suggested that we use the money to get street lighting on both sides of the highway. Dale checked with DOT and they said it was an ineligible expense. Dale will work on our other options.
- 2. Matt spoke to Dave Vorwald, DPW-Dyersville, about the potential purchase of the dump truck that we brought to the board last month. The price is firm \$42,500.00 and will be available at the end of April or out of the snow season. We will make a motion on the purchase at the April 2018 meeting.
- 3. Work will commence soon. The frost should be out of the ground, so Wiederholt Excavating will be able to complete the job.
- 4. Dale wanted to know if the Board is going to pursue action to install a new sewer line that could eventually connect to the IP. Dale suggest that we meet with Ron Brisbois, of the Grant County Economic Development Corporation, who has ideas on how to fund the line. Dale recommended that we start setting monies aside for this. The Board will talk about this later.
- 5. Dale has seen preliminary plans for the water main replacement project on Domi Avenue. He suggested two changes to KD Engineering. We cannot go out for bid until we receive confirmation from the state that they approve the street repair project. As of today, we have not received the money from last year's S. Church Street overlay project.

- 6. We are on the 10-year timetable for phosphorus reduction. This report is due June 30<sup>th</sup> and is complete except for some test data that still needs to be done.
- 7. Kathy Bresnahan will be at the Brickl Memorial Library on May 5 for a book signing. The Miracle Season was also made into a movie that is due to release sometime in April starring Helen Hunt, who plays Kathy in the movie. More information on the Library report.
